Chichester Youth Adventure Trust Annual Report 2019

Public Benefit Declaration

The Trustees have paid due regard to the Charity Commission's guidance on public benefit.

Our charity's aim is to help and educate young people through their leisure time or educational activities.

Continued work has been undertaken at the bunkhouse to improve the accommodation and to ensure the health and safety requirements are met.

We have regular groups of young people visiting the bunkhouse, participating in a range of outdoor activities. The young people not only experience and develop skills in the outdoors, but also develop their independence and their social skills whilst away from home and living with others. This year we have seen a slight decrease in the number of young people using the bunkhouse, which we will keep a close eye on and continue to find ways to promote the bunkhouse to youth organisations.

There are also a number of adult groups who use the bunkhouse when it is available, and their revenue assists with the day to day expenses of running the place, enabling the young people to stay at the centre at a reduced price.

The following reports incorporate how the charity continues to meet its aim.

Report of the Trustees

Chair's Report

It's hard to believe that 35 years ago Tyle Morgrug, a dilapidated 200 year old Welsh farmhouse, was purchased and the dream of Anne Scicluna, the trust's founder and president,

was fulfilled when, as Mayor of Chichester, she founded The Chichester Youth Adventure Trust charity.

To mark the occasion I thought that my report, this year, would consist of a precis of the interview held with Anne for an article that appeared in the Chichester Observer newspaper on the 28th February 2019:

"As a youth worker, Anne had seen many youth organisations taking young people to centres away from home, teaching skills such as leadership, confidence, self sufficiency and working together as well as learning practical and outdoor activity skills.

She thought Chichester needed a centre of its own, 3 to 4 hours away in wild country that could also be used by youth and adult groups outside the Chichester area.

A place was found which, although not in good repair, already had planning consent and had been used for several years as a bunkhouse and it was purchased for £8,000. Money was raised by youth groups and schools in the Chichester area and the building started to be used. Mornings were spent on simple renovations, afternoons on activities.

Anne said:

Happy 35th Birthday to Tyle Morgrug- you have housed many thousands of young people over the past 35 years. You have helped them to develop into useful citizens. Many have returned as leader, giving back what they received from you. At the beginning you did not even have glass in your windows, but now you have central heating, modern amenities and bright comfortable rooms. Many of the teenagers who worked on the hill farm many years ago are now parents themselves. It is to be hoped that many remember the fun and practical enjoyment they had staying within Tyle Morgrug`s stone walls. The trustees look forward to the next 35 years and hope you will still be going strong and looking after future generations of young people and adults who visit you."

That was how it all started and thanks to an enthusiastic group of trustees and volunteers working tirelessly to raise money and carry out the necessary improvements Tyle Morgrug (which means "little ant house" in Welsh) is now a popular, self financing, 3 star bunkhouse listed by Visit Wales Tourist Board as "one of the top 10 brilliant bunkhouses in Wales."

It's been a pleasure and privilege, for me, to have been involved with the bunkhouse: bringing groups there in the early days, then as a participant on work parties and latterly as a trustee and now chair of trustees. Tyle Morgrug has enriched my life, given me new friends, rich experiences, great fun, a sense of purpose and just a few headaches! Long may it last.

And finally the icing on the cake: year 35 has been another good one although our user numbers are down on last year and consequently so is the bookings revenue. I don't see this as alarming, but something that we should be mindful of, as we move into 2020 and I see no reason why the next year should present us with any unpleasant surprises.

Honorary Treasurer's Report

The annual return was filed with the Charity Commission with trustee details updated.

Regarding the water supply follow up questions arising from the questionnaire completed in October 2018 were answered before a site visit in October 2019 to redo the risk assessment to cover the next five years. The life expectancy of the UV 'filter' system is to be investigated. During the year some results were over the permitted limits as a result of contaminants introduced when fixing a blockage in the supply earlier in the year. The numbers have been brought down below the parameters since and to keep it there the risk assessment has asked us to establish a method of cleaning the supply from the spring to the centre.

As water testing has become a significant expense it has been shown as a separate expense.

As regards the accounts, income from groups staying at the centre on a cash received basis was some £4,000 down on the previous year and the amount received in advance of the following year's bookings has decreased from £2,730 to £1,530.

The overall surplus for the year was £8,346, an increase of £749 over the previous year as there were no major projects that we ended up bearing the cost of and repairs and maintenance were also lower. Our cash reserves have increased from £38,209 to £46,555.

Grants and donation received in the year were £791 a small increase on last year thanks to £446 from Waitrose. Interest receipts increased as the balance on deposit also increased from £33,000 to £43,000.

The Calor Gas contract was renewed for a further year but with an increase of 5%. When gas is needed the supplier is now automatically notified.

Forms were completed to keep us an approved centre on West Sussex County Council's list.

Building Maintenance, fabric, furnishing and fittings

Regular general maintenance has been carried out by our caretaker, and trustees and volunteers on working visits, together with specialist input from our very reliable tradesmen team. This has ensured that the building is maintained to the highest standard

and that our "zero tolerance" policy in dealing with any issues that arise is adhered to. There is always something that needs to be done to an old building that is heavily used, mainly by young people, but the place is respected by users with fair wear and tear and virtually no incidents of vandalism. Work has included:

- Establishing a leader's sleeping pod above the stairs in the dormitory to provide a higher level of supervision and privacy.
- Decor improvements to the inner downstairs hall.
- Replacement of most of the light fittings in the dormitory. They had been replaced last year, but were found to be faulty and replaced under guarantee.
- Replacement of the plastic electrical fuse box in order to comply with recent electrical fire safety regulations (the plastic one was not fire proof.)
- Provision of 2 camp beds to give enhanced flexibility with sleeping arrangements. They were mistakenly taken away by a group, but later returned.
- There has been an ongoing problem with bacterial contamination with our water supply, which is not connected to the mains, and drawn from our own spring. We reckon to have solved the problem by cleaning the internal storage tank and pipes, but will now also need to clean the external pipes and storage tank. A regular cleaning procedure has been instigated.

Outdoor Maintenance

The exterior of the building and grounds have continued to be low maintenance, but major work has taken place to the track and we need to have a tree safety survey carried out in the near future. Work has included:

- Cleaning of the rear patio and erecting a sign to warn that the surface can be slippery when wet.
- Strengthening the bank of a section of the river which runs beside the track leading from the lane to our neighbour's house. The bank had become badly eroded with the strong possibility that a section of the track could get washed away. That section of track and adjacent ground is owned by our neighbour and we, and the local farmer, have a right of access over it. The major cost of the work was covered by the landowner. We carried out clearance work and the cost of the new fence will be shared between us and the farmer.





There has been an increase in bookings from adult organisations but a decrease in those from youth groups. There has been a reduction in bookings from previous years for the Prince's Trust, which has attributed to the reduced youth usage.

The twelve year trend line shows a decrease over the year and seems to have settled to about 45%.



There were just a few problems during the year. Thanks must go the understanding of hirers, especially Prince's Trust Cardiff, and the Caretaker, Andrew Jones in sorting out these problems.

The key safe was moved from the caretaker's house to just by the back door and a new combination lock fitted to the middle gate.

The bunkhouse website

Figure 1: Jan 01 2019 - Dec 31 2019





Figure 2: Jan 01 2018 - Dec 31 2018

4 Trustees' Remuneration, Expenses and Benefits

No trustee or person connected to them received any remuneration or benefits during the year (2018: nil) A total of £533 (2018 £635) was reimbursed to seven (2018: seven) of the Trustees in the year. This was reimbursement for actual costs incurred in travel to and from the Cottage & Bunkhouse for work party weekends and the Annual Meeting there and postage, telephone and stationery costs.

5 Risk Management

The Trustees have carried out a Risk Assessment audit of all the major risks relating to its operational base i.e. the Cottage & Bunkhouse. They actively review this on a regular basis, and are satisfied that systems are in place to mitigate their exposure to major risks.

6 Reserves Policy

The General Fund represents unrestricted funds arising from past operations.

The trustees aim to keep sufficient reserves to maintain services to hirers, to meet any unforeseen maintenance expense and to keep the property well maintained.

The aim is to keep at least one year's running costs in reserves

Additional reserves are in hand to meet the anticipated cost of upgrading the track (£15,000) and work on the trees around the centre which are showing signs of ash dieback.

Restricted Income Funds are amounts received by way of grants and donations for specific schemes
